

Section on Pediatrics Clinical Residency or Fellowship Program Grants

Policy

The Section on Pediatrics will award \$3,000 per year to assist potential pediatric residency and fellowship programs with the APTA credentialing process. This money will be made available on a “first come, first served” basis in the form of 2 grants in the amount of \$1500 each, for reimbursement of the credentialing application fee. Up to two grants will be awarded per year. Applicants will be eligible for only one grant regardless of the number of applicants each year.

The committee will consider grant applications on a “first-come, first-served” basis in two rounds throughout the calendar year.

For the first round, the grant application deadline is March 1.

For the second round, the grant application deadline is September 1.

Application Process

- The pediatric residency or fellowship program will submit the grant application to the Section on Pediatrics Executive Office within 45 days of submitting credentialing applications to the APTA. The grant application deadline is March 1 for the first round, and September 1 for the second round, of each year.
- Upon receipt of the program’s credentialing status by the credentialing committee of the APTA, the Education Department will notify the Section on Pediatrics Executive Office.
- The Section on Pediatrics Residency Grant Subcommittee will notify the pediatric residency or fellowship program that the grant has been awarded by either electronic mail or standard mail sometime after September 1.
- The Section will then send a reimbursement check for the program’s application fee directly to the applicant contact person.
- If the Section on Pediatrics Executive Office does NOT receive APTA’s letter acknowledging the residency or fellowship program’s credentialing status within 30 days beyond the announced target date, the residency or fellowship program will forfeit the grant.
